

# Language Learning and Teaching in Digital Transformation

### 1-2 September 2023

The conference will respond to digitalization in education, and specifically in language learning and teaching (Gee & Hayes, 2011), by integrating transdisciplinary perspectives on language education. It will explore language as a complex semiotic assemblage (Blommaert, 2010) and meaning-making practice (Lytra et al., 2022) with its material dimensions such as embodiment, sign language and gesture (Kusters, 2021), on the intersection of textuality and tactility (Thurlow, 2020). In highlighting the impact of everyday digital language practices (Androutsopoulos, 2016) and the recent developments in multimodal and digital literacy in language learning and teaching (Brown & Hao, 2022; Hilfsdorf Rocha, 2022), the conference will focus on the ongoing discourse on rewilding (Thorne et al., 2021) and liberating language education (Lytra et al., 2022). We are particulary interested in the relationship between fluid everyday language practices and language ideologies in contemporary language education, and in ascertaining the competences, attitudes and knowledge required to advance digital citizenship and socially responsive language education. The conference invites researchers and practitioners to discuss theoretical and methodological approaches and empirical evidence, and to share experiences in digitally transformed language learning and teaching.
